## 12:15 | Panel of Experts – Part I: Identification of prospective directions/areas for coal research in Europe

- What technologies will be important for coal exploitation in the 21<sup>st</sup> Century?
- What incremental research could lead to transformational change in coal mining?
- Coal and climate is CCS the only answer?
- Does improved efficiency and flexibility at coal-fired power plants have a role in the EU?
- Are other conversion technologies important (coal-to-X)?
- RFCS versus EU Framework Programmes why a unique coal and steel programme is needed
- What are the pros and cons of international collaboration with coal researchers outside of the EU?
- What strategic themes should be included in a new coal R&D roadmap for the EU?

Is there a role for a large, ambitious clean coal project to showcase EU technologies?

A principal goal for this panel is to identify research questions and explore some of the most important research directions that have high relevance to future of coal and will help establish the future research priorities for the RFCS Research Programme. Participants will be invited to share their opinions on the posted questions (questionnaire survey).

The results of this survey make a base for Delphi process to reach a European consensus on issues of the study, i.e. future of Coal in Europe 2051.

## Panel of Experts – Part II: Identification of factors/criteria determining the future of coal research in Europe

Experts will be invited to make a short statement in response to the questions posed by the workshop. This will be followed by open discussion with the aim of informing the direction of the CoalTech2051 project.

Participants will be invited to the process of developing the criteria for foresight survey, i.e. factors that determine the future directions of research, as social, economic, legal, technological, environmental once that stimulate or hinder the development of coal research in the 2051 perspective.
